CONSULTATION ON ADMISSION ARRANGEMENTS FOR 2026/27

Consultation on the inclusion of an oversubscription priority group for Year 11 students on roll at Harrogate Grammar School applying as external Sixth Form applicants to Rossett School, Harrogate

As the admission authority for Rossett School, Red Kite Learning Trust is carrying out a consultation on its admission arrangements for the academic year 2026/27.

Proposal

Following review by the school's Executive Board, Senior Leadership Team, Red Kite Learning Trust Board, and North Yorkshire Council (NYC) as the local authority, Rossett School proposes:

- Inclusion of an oversubscription priority group for Year 11 students on roll at Harrogate Grammar School that meet the Rossett School academic requirements for entry into the Sixth Form as external applicants

All other criteria will remain the same, other than where wording revisions may be necessary to give effect to a mandatory requirement of the School Admissions Code (2021) or admissions law.

The consultation will open on 3rd December 2024 and the deadline for responding with any comments is 21st January 2025.
